LETTER FROM THE EXECUTIVE DIRECTOR, NICK ULLO

WEATHERING THE STORM: Boothbay Region Land Trust Faces New Challenges Amidst Climate Change

As the impacts of global climate change become increasingly evident, communities around the world are grappling with the consequences of more extreme weather patterns. The Boothbay region in Maine is no exception, experiencing stronger storms and unpredictable weather that are taking a toll on the local environment. 




